Deposit Policy:

At time of booking, a \$2500 (\$500 of which is **non-refundable**) deposit is due from each Participant to secure booking.

Cancellation Policy:

All cancellations must be in writing and sent to via email to r.basye@asld.org. Cancellation fee payment must be received within 15 days of your cancellation. In case of cancellations received:

- 61 days or more before departure date: Participant forfeits the \$500 non-refundable deposit and pays all penalties or cancellation fees assessed for cancellation pre-paid tour costs and purchases will be fully refunded to Participant.
- 60-45 days before departure date: Participant forfeits the \$500 non-refundable deposit, plus 50% of balance. Any remaining amount will be refunded to Participant.
- 44-31 days before departure date: Participant forfeits the \$500 non-refundable deposit, plus 75% of balance. Any remaining amount will be refunded to Participant.
- 30 days or less before departure date: no refunds will be made.
